
APPLS Strategic Discussion


- Advocating for funding of systems

 up and project management
- I'm not certain that we can sustain APPLS at a level that justifies creating a 501 c 3. It is the membership of APPLS that has to drive our agenda and activity, and I don't see how administrative support will make us stronger.
